Transportation: to Confrontation Point is provided. When we leave and return – TBA.

Things to bring: Clothes that you can get messy, sturdy work site boots/shoes, Bible, pen, flashlight/headlamp, sleeping bag, sleeping pad, pillow, towel, flip flops for the shower, bathing suit and cover up, toiletries and water shoes if we swim.
